BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$307,962.40 by R.E. Hazard Contracting Co., a corporation, for IMPROVEMENT OF BLACK MOUNTAIN ROAD FROM MIRAMAR ROAD TO MIRA MESA BOULEVARD, Base Bid, and including Optional Alternate "A", Additive Alternate 1, and Optional Alternate "B", in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. 743359.
2. That the expenditure of \$323,648.05 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF BLACK MOUNTAIN ROAD FROM MIRAMAR ROAD TO MIRA MESA BOULEVARD, Base Bid, and including Optional Alternate "A", Additive Alternate 1, and Optional Alternate "B", in the City of San Diego, and related costs.
3. That the contribution of \$24,351.95 from Anderson Realty, Inc. for the Subdivider's share of the construction costs to be used for the above purpose is hereby accepted.
