

RESOLUTION No. 208899

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$75,326.00 by DBX, INC. dba Perry Electric, a corporation, for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF LA JOLLA VILLAGE DRIVE, VILLA LA JOLLA DRIVE, VETERAN'S ADMINISTRATION DRIVE AND GENESEE AVENUE AND APPLETON STREET/LEHRER DRIVE, Schedules I and II, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. 744501.
2. That the expenditure of \$77,000 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF LA JOLLA VILLAGE DRIVE, VILLA LA JOLLA DRIVE, VETERAN'S ADMINISTRATION DRIVE AND GENESEE AVENUE AND APPLETON STREET/LEHRER DRIVE, Schedules I and II, in the City of San Diego and related costs.
3. That the contribution of \$10,000.00 from the University of California San Diego to be used for the above purpose is hereby accepted and the City Council hereby express their gratitude for this contribution.
