The City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 1 to District Agreement No. 11-0104 with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, to provide for the modification of signals and lighting at Naval Station Gates 3 and 6 on Rosecrans Street, under the terms and conditions set forth in the form of Amendment to Agreement No. 1 on file in the office of the City Clerk as Document No. 745035.

BE IT FURTHER RESOLVED, that the expenditure of \$3,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing the City's estimated share of costs and supplementing Resolution No. 204840 in this amount.
