

RESOLUTION NO. 208923

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Frances L. Davis	BUILDING INSPECTION DEPARTMENT	\$90	Each year when renewal bills for Business Licenses, Housing, and Mobilehome Park Permits are sent out, about 300 are returned because of a change in ownership. A great deal of clerical and Field Inspector time was spent trying to get the name and address of the new owners. Mrs Davis, a Senior Typist, proposed getting this information from the Error/Inquiry/Investigation file for Water Utilities in Data Processing. This has saved a net of \$911 per year.
Alexander Gojkovich	POLICE DEPARTMENT	\$60	Officer Gojkovitch became concerned with the method of obtaining warrants from the Marshall's Office for prisoners which are in the patrol car outside the Marshall's office. As a result of his suggestion, a Deputy Marshall will bring the warrant out to the waiting officer after he has rung a buzzer calling for the Deputy Marshal. This makes it unnecessary for the officer to call for a cover unit while he goes up to the Marshall's office. It is estimated this saves \$600 a year in patrol officers time.
Carla D. Pickett	EMPLOYEE SERVICES	\$10	Mrs. Pickett, an Intermediate Typist in the Claims Division proposed that special envelopes for Recovery Files be used twice instead of discarded after each case is closed. They cannot be used more than twice. This saves \$60 worth of special envelopes each year.
