1. That the bid of \$39,599.00 by Wilcox Electric dba Arrow Electric, a corporation, for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF 19TH STREET AND CORONADO AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744619.
2. That the expenditure of \$46,500.00 is hereby authorized out of the Gas Tax Funds (220) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF 19TH STREET AND CORONADO AVENUE in the City of San Diego, and related costs.
