

RESOLUTION NO. 208962 OCT 4 1973

APPROVING MAP OF SOUTH BAY TRAILER PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, and entitled "SOUTH BAY TRAILER PARK Being a subdivision of portions of Lots 1 and 2 of Bayview Drive-In Theatre Tract No. 2, according to Map thereof No. 4493, filed in the office of the County Recorder of San Diego County, March 30, 1960, together with portions of Lots 8 through 15 inclusive, of Nestor Acres, according to Map thereof No. 1768, filed in the office of the County Recorder of San Diego County, November 21, 1923, together with a portion of Coronado Avenue as dedicated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following portion of street: portion of Elm Avenue for public purposes, and said portion of street is hereby declared to be portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement, with the right of ingress and egress, for the construction

and maintenance of sewer facilities, all as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that that certain easement, with the right of ingress and egress, for the construction and maintenance of sewer facilities, as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby authorized and directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
