

RESOLUTION NO. 208969 OCT 9 1973

APPROVING MAP OF MAR SCENIC HEIGHTS SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by VICTOR T. WIGLESWORTH, a Registered Civil Engineer, and entitled "MAR SCENIC HEIGHTS Being a subdivision of Lots 1 and 21 in Block 28, and a portion of that certain land designated as 'Reservoir' together with a portion of the alley in Block 28 and portions of Del Mar Heights Road (formerly 4th Street) and Mar Scenic Drive (formerly San Dieguito Place) between Block 28 and 'Reservoir,' and a portion of Nogales Drive (formerly Mesa Avenue), lying Westerly of and adjacent to Block 28, all as closed and vacated to public use, all being in Del Mar Heights, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 157 filed in the office of the County Recorder of San Diego County July 8, 1897.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities; together with the access

easement over, upon, along and across Lot 4, all as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said easement with the right of ingress and egress for the construction and maintenance of sewer facilities, together with the access easement over, upon, along and across Lot 4, as granted and shown on said map, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
