

RESOLUTION NO. 208971 OCT 9 1973

WHEREAS, the City Council of The City of San Diego, established the Scott Street Underground Utility District by Resolution No. 204772 adopted February 1, 1972; and

WHEREAS, said Resolution No. 204772 was amended by Resolution No. 205546, adopted May 10, 1972, which amendment established the date of December 1, 1972 as the date upon which the property in the district must be ready to receive underground service, and the date of February 1, 1973 as the date for the removal of all poles, overhead wires and associated overhead structures and the installation of all underground facilities; and

WHEREAS, the undergrounding of utilities along Scott Street is to be coordinated with a street widening project funded in part by TOPICS, which contract for the street work was awarded by Council on August 7, 1973; and

WHEREAS, because of the time that elapsed in obtaining the various governmental approvals prior to the award, it is necessary to amend the customer ready and pole removal dates which were previously established in May, 1972; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 204772, adopted February 1, 1972, establishing the Scott Street Underground Utility District, as amended by Resolution No. 205546, adopted May 10, 1972, is hereby

amended in part by amending Section 2 to read as follows:

"2. The City Council does hereby fix the date of November 1, 1973 as the date upon which the property in the district must be ready to receive underground service, and does hereby order the removal of all poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within said district by February 1, 1974."

2. That the City Clerk is hereby directed to renotify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within ten (10) days after the date of such adoption. The City Clerk shall further notify said affected persons of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall provide, at their own expense, all necessary facility changes on their premises so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California as of the date of adoption of this resolution and subject to all other applicable requirements of

State law and City ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.
