BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$11,000 from Gas Tax Fund 220 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for construction of a ten-foot bicycle lane within the Fay Avenue right of way from Via del Norte to Nautilus Street in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City Forces more economically than if let by contract.
