

RESOLUTION NO. 209007 OCT 11 1973

RESOLUTION AMENDING PLANS AND SPECIFICATIONS SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 208841 FOR THE IMPROVEMENT OF CAMINO DE LA REINA BETWEEN CAMINO DEL ESTE AND A POINT APPROXIMATELY 550 FEET WESTERLY OF MISSION CENTER ROAD; AND MISSION CENTER ROAD BETWEEN CAMINO DEL RIO NORTH AND A POINT APPROXIMATELY 950 FEET NORTHERLY OF CAMINO DE LA REINA, AND APPROVING THE PLANS AND SPECIFICATIONS SO AMENDED

(Camino de la Reina Assessment District)

WHEREAS, this Council did on September 18, 1973, adopt Resolution of Intention No. 208841, declaring its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done in said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of CAMINO DE LA REINA BETWEEN CAMINO DEL ESTE AND A POINT APPROXIMATELY 550 FEET WESTERLY OF MISSION CENTER ROAD; AND MISSION CENTER ROAD BETWEEN

CAMINO DEL RIO NORTH AND A POINT APPROXIMATELY 950 FEET NORTHERLY  
OF CAMINO DE LA REINA, heretofore filed in the office of the City  
Clerk as Document No. 744873 and approved by Resolution No.  
208841, be and the same is hereby amended in accordance with the  
Schedule of Changes, attached hereto, marked "Exhibit"<sup>A</sup> and  
incorporated by reference herein; and the same, as so amended,  
are hereby approved and adopted as the official drawings, typical  
cross-sections, profiles and specifications for said work and  
improvement.

SCHEDULE OF CHANGES

I. SPECIFICATIONS. The following changes are made in the specifications.

- (1) Section D-07.02 modified by stipulating permitted periods of shut down of traffic signals (Addendum A).
- (2) Section D-14 added to include the specifications on cast-in-place concrete pipe (Addendum A).
- (3) Bid opening date extended to October 10 (Addendum B).
- (4) Section A-03 modified by deleting certain items in the bid schedule and modifying the unit quantities in certain other schedules (Addendum C).
- (5) Section C-06 revised by clarifying the work involved schedule to show the water main in Mission Center Road (Addendum C).
- (6) Page A-1(2) revised to reflect modification to the index (Addendum C).
- (7) Bid opening date extended to October 17 (Addendum D)

II. PLANS. The following changes are made in the plans.

- (1) Sheets 15813-2-D, 3-D, 5-D, 6-D, 7-D and 8-D modified to include minor revisions to the work involving the existing curb on the south side of Camino de la Reina and street grades within several areas; and to show riprap elevations at the top and toe of the slope along the northerly boundary of the project (Addendum A).
- (2) Sheets 15813-4-D and 9-D modified by deleting the sewer in Mission Center Road and modifications to the controller specifications on the intersection of Mission Center Road and Camino de la Reina (Addendum C).
