RESOLUTION ORDERING WORK TO IMPROVE AND ESTABLISH THE GRADE ON CAMINO DE LA REINA BETWEEN CAMINO DEL ESTE AND A POINT APPROXIMATELY 550 FEET WESTERLY OF MISSION CENTER ROAD; AND MISSION CENTER ROAD BETWEEN CAMINO DEL RIO NORTH AND A POINT APPROXIMATELY 950 FEET NORTHERLY OF CAMINO DE LA REINA

(Camino de la Reina Assessment District)

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the public interest and convenience require the improvement herein referred to, and that this Council hereby orders that the work and improvement as described in Resolution of Intention No. 208841, passed and adopted by the City Council on September 18, 1973, and the plans, profiles and specifications therein referred to, as amended by Resolution No. 209007, passed and adopted by the City Council on OCT 11 1973, be done and made.

2. That the boundaries of the district to be assessed and the grades to which said work is to be done, shall be those described in said Resolution of Intention, and the plans, profiles and specifications therein referred to, as well as in said Resolution No. 209007, reference to which is hereby made for all particulars.

3. The Council hereby orders said work and improvement, having fully considered the contents of the Environmental Impact Report, EIR-E.Q. File # 72-11-1064P, and the Council hereby finds that social and economic factors justify the work and improvement

and outweigh any environmental factors.
