
Adopted on OCT 11 1973

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BLAYLOCK-WILLIS AND ASSOCIATES for engineering services in connection with the design of the widening of Beyer Way, between Palm Avenue and the north City Limits, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745175.

BE IT FURTHER RESOLVED, that the expenditure of \$65,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for said engineering services.
