
Adopted on OCT 11 1973

BE IT FURTHER RESOLVED, that the expenditure of \$8,300 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for said soils engineering services.
