


RESOLUTION No. 209020

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO and INDIAN CENTER, for the purpose of establishing a center for Indian people in order to deal with their problems such as alcoholism, unemployment and disease as part of the City-County program of using Revenue Sharing Funds for the operation of human care services as approved by Resolution No. 208955 on October 2, 1973, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745184.
