

RESOLUTION NO. 209028 OCT 16 1973

APPROVING MAP OF DIVISION HIGHLANDS UNIT NO. 3  
SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled "DIVISION HIGHLANDS UNIT NO. 3 Being a subdivision of a portion of the Northerly Half of Quarter Section Lot 79 of Rancho De La Nacion according to Map thereof by Morril No. 166 and a portion of Lot 29, Map of Encanto according to Map thereof No. 749, all being in The City of San Diego, County of San Diego, State of California, on file in the County Recorder's office of said San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets: Daisy Way, Daisy Avenue, Daisy Place, and Division Street, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Division Street, adjacent and contiguous to Lots 87 through 94, all as shown and granted on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
