

RESOLUTION NO. 209035 OCT 16 1973

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City Auditor and Comptroller is hereby directed to create appropriate accounting records within Supplemental Transportation Programs Fund 2554 solely and exclusively to be used to delineate the lease of one passenger van vehicle and one compact station wagon, and the purchase of two 2-way radios, automobile insurance, hire one van driver and one transportation coordinator driver and provide funds to operate a Dial-A-Bus system in Linda Vista.


BE IT FURTHER RESOLVED, that said Dial-A-Bus system shall have a fare of 25¢ per person, be restricted to the general Linda Vista area, and shall terminate eight months from the date of this resolution.

BE IT FURTHER RESOLVED, that the City Manager is to negotiate transfer provisions for the Dial-A-Bus system to the San Diego Transit Corporation, and develop criteria for the operation of the Dial-A-Bus system based on need; the City Manager shall also make quarterly reports to the Council on the progress of this project.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to hire one van driver and one transportation coordinator driver in order to implement the Dial-A-Bus system in Linda Vista.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized and directed to transfer the sum of \$34,682 of the Public Transportation Reserve Fund 2571 to the Supplemental Transportation Programs Fund 2554 solely and exclusively for the purpose of funding the Dial-A-Bus system in Linda Vista as delineated above.
