

RESOLUTION NO. 209042 OCT 16 1973

WHEREAS, the U. S. Government and Mexican officials have indicated a desire to open an additional border crossing on Otay Mesa easterly of Brown Field and the Tijuana Airport; and

WHEREAS, acceptable highway access to such a crossing is dependent upon construction of State Highway Route 75 to a connection with Otay Mesa Road westerly of Brown Field; and

WHEREAS, the State of California has awarded a contract for construction of I-805 which will provide the interchange with Route 75; and


WHEREAS, the State has not yet awarded a contract for construction of Route 75 from the I-805 interchange to Otay Mesa Road as specified in the freeway agreement between the State and the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the California Highway Commission and the California Department of Transportation are requested to accelerate financing for Route 75 from I-805 to Otay Mesa Road and to proceed with construction of this highway as soon as possible in order to permit an early opening of a new border crossing point on Otay Mesa easterly of Brown Field and the Tijuana Airport.

2. That the California Highway Commission and the California Department of Transportation coordinate with the appropriate Federal agencies in the preparation of an environmental impact statement on this project.
