That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with the GIRLS SCOUTS, SAN DIEGO - IMPERIAL COUNCIL, INC., for the purpose of increasing both girl and adult membership in girl scouting in San Ysidro and Southeast San Diego and other minority areas, and to help girls mature into self-directed, contributing citizens with increased skills, broadened interests, and experience in using their abilities in cooperation with others to better their own communities and society as part of the City-County program of using Revenue Sharing Funds for the operation of human care services as approved by Resolution No. 208955 on October 2, 1973, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745269.
