That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with SAN DIEGO YOUTH SERVICES, INC., for the purpose of providing 24-hour out-of-home placement for adolescent males and females fourteen to eighteen years of age who are mildly disturbed, mildly delinquent, or mild soft drug users of average or above average mental ability as part of the City-County program of using Revenue Sharing Funds for the operation of human care services as approved by Resolution No. 208955 on October 2, 1973, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745276.
