RESOLUTION OF AWARD

(Camino de la Reina Assessment District)

WHEREAS, on September 18, 1973, the Council adopted Resolution No. 208842 directing that sealed bids and proposals for the construction of the work and improvement hereinafter referred to be invited; and

WHEREAS, notice inviting such sealed bids and proposals was duly published and posted, said notice having called for bids and proposals to be submitted and opened on October 3, 1973; and

WHEREAS, certain addenda to the plans and specifications for said work and improvement were promulgated and all bidders and prospective bidders were given timely notice of said addenda, and said addenda were approved by Resolution No. 209007, adopted on OCT 11 1973, ~~1973~~; and

WHEREAS, the date for submission and opening of bids and proposals was delayed from October 3, 1973, to October 10, 1973, and again from October 10, 1973, to October 17, 1973, and all bidders and prospective bidders were given timely notice of such delays; and the Council hereby determines that such delays were and are in the public interest; and

WHEREAS, the Purchasing Agent of the City of San Diego, California, did on October 17, 1973, publicly open, examine and declare all sealed proposals or bids for doing the work and

improvement described in Resolution of Intention, Resolution No. 208841, as amended by Resolution No. 209007, which Resolutions are hereby referred to for a description of said work and improvement, and for all particulars relative to the proceedings under said Resolution of Intention; NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council hereby ratifies and affirms the delay in the submission and opening of sealed bids and proposals from October 3, 1973, to October 10, 1973, and from October 10, 1973, to October 17, 1973.

2. The Council hereby rejects all said proposals or bids except that herein mentioned and hereby awards the contract for doing said work and improvement to the lowest regular responsible bidder, to wit:

 GRIFFITH COMPANY,
at the prices named in the Bid of said bidder on file in the Office of the City Clerk.

3. The City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the Office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.
