

RESOLUTION No. 209093

Adopted on OCT 25 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an operating agreement with Ace Auto Parks, Inc., for the San Diego Stadium Parking Facility for a period of five years and six months at a rental of 88 percent of gross income for two years and 87.5 percent of gross income thereafter, except during each football season when these rates shall apply only to the first \$250,000 of gross income from football games per year and the rate of 95 percent shall apply to all gross income exceeding \$250,000, under the terms and conditions set forth in the form of operating agreement on file in the office of the City Clerk as Document No. 745287.
