


RESOLUTION No. 209036

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$41,765.00 by Wilcox Electric, Inc., a corporation, dba Arrow Electric for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT FIFTH AVENUE AND UPAS STREET, AND QUINCE STREET AND SIXTH AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744536.
2. That the expenditure of \$47,600.00 is hereby authorized out of the Gas Tax Fund (220), and that the expenditure of \$2,400.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT FIFTH AVENUE AND UPAS STREET, AND QUINCE STREET AND SIXTH AVENUE, in the City of San Diego, and related costs.
