

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$55,642.00 by Gaylord F. Arnold, an individual, dba GFA Electric for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT FELSPAR AND INGRAHAM STREETS, AND 65TH STREET AND IMPERIAL AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744537.

2. That the expenditure of \$65,500.00 is hereby authorized out of the Gas Tax Fund (220), and that the expenditure of \$1,500.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT FELSPAR AND INGRAHAM STREETS, AND 65TH STREET AND IMPERIAL AVENUE, in the City of San Diego, and related costs.
