BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, District Agreement Nos. 11-0129, 11-0130 and 11-0131 with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, relating to the construction of separate lighting conduits in conjunction with State's installation of traffic signals at various ramps and streets affected by the construction of Interstate Route 805 and the Balboa Avenue/Route 163 interchange complex, under the terms and conditions set forth in the form of District Agreements on file in the office of the City Clerk under Document Nos. 745321, 745322 and 745323, respectively.

BE IT FURTHER RESOLVED, that the expenditure of \$8,975 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for City's estimated share of costs.
