

RESOLUTION No. 209115

Adopted on OCT 30 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on both sides of the following streets in said City:

PROSPECT STREET, between Cuvier Street and Draper Street;

DRAPER STREET, between Silverado Street and Kline Street; and

SILVERADO STREET, between Draper Street and Eads Avenue.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
