public street purposes.

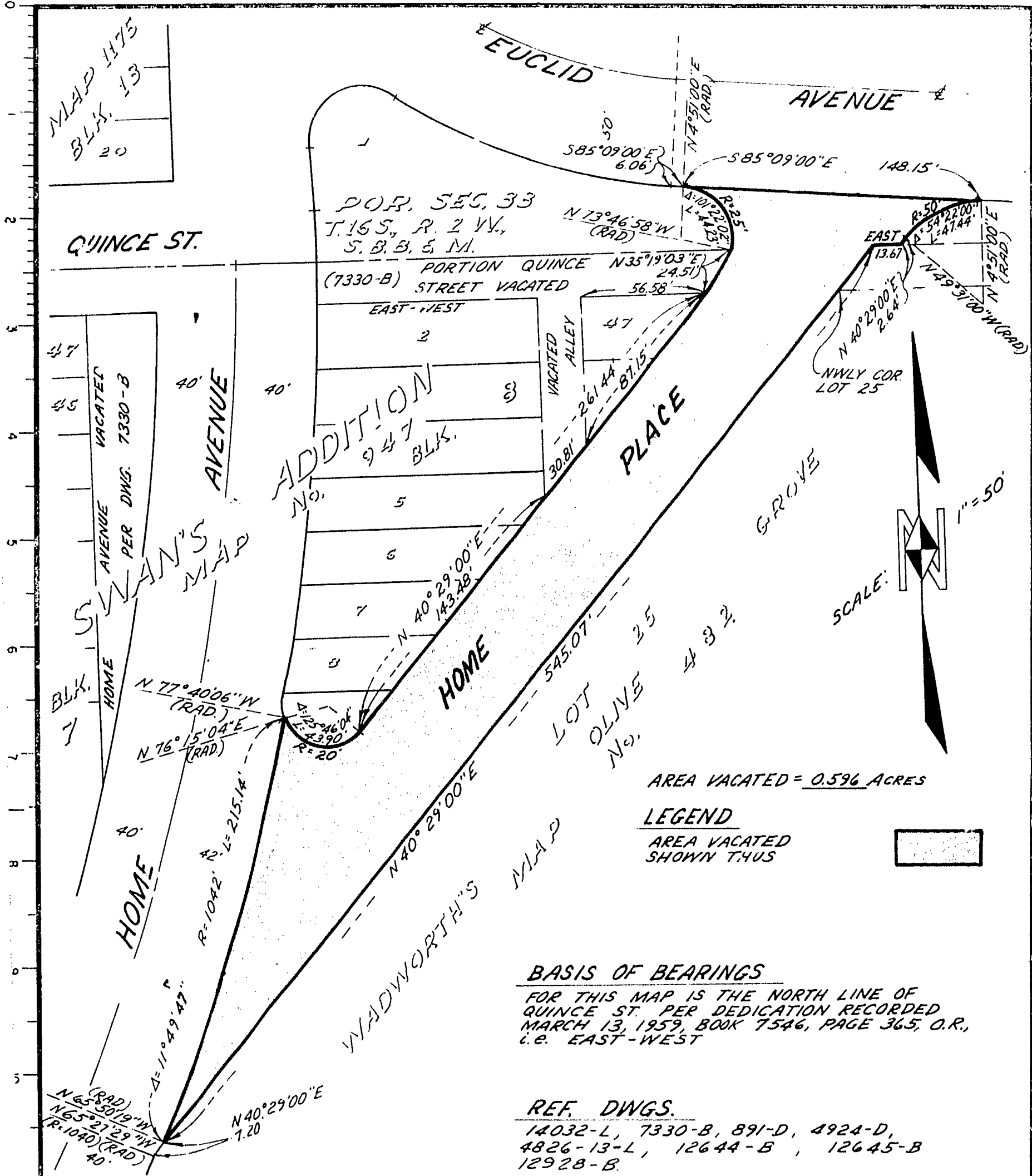
BE IT FURTHER RESOLVED, that HOME PLACE between Home Avenue
