

RESOLUTION NO. 209118 OCT 30 1973

APPROVING MAP OF ROY-AL UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by DON NASLAND, Licensed Land Surveyor, and entitled "ROY-AL UNIT NO. 1 Being a subdivision of a portion of Lot 25 of Wadsworth's Olive Grove Addition, according to Map thereof No. 482, filed in the office of the County Recorder of San Diego County, February 10, 1888, and a portion of the Southwest Quarter of the Northeast Quarter of Section 33, Township 16 South, Range 2 West, San Bernardino Meridian, according to official Map thereof; together with Quince Street (formerly Ohio Avenue) and a portion of Home Place as said streets were vacated and closed to public use, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following portions of public streets: portion of Home Avenue and portion of Euclid Avenue, for public purposes, and said portions of street are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
