

RESOLUTION NO. 209124 OCT 30 1973

APPROVING MAP OF RESUBDIVISION OF LOTS 491 & 494
BAY TERRACES UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "RESUBDIVISION OF LOTS 491 & 494 BAY TERRACES UNIT NO. 1 Being a resubdivision of Lots 491 and 494 of Bay Terraces Unit No. 1, together with portions of Alta View Drive, Parkside Avenue, Woodman Street, Ramfos Place, Aegean Drive and Paris Way as dedicated to public use, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6659, filed in the office of County Recorder of San Diego County, June 1, 1970.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets: Aegean Place, Aegean Way, Parkside Court, Ramfos Circle, Ramfos Lane, Simi Way, Simi Place, and Quebec Court, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Woodman Street, adjacent

and contiguous to Lots 82 through 94 inclusive, 115 through 118 inclusive, 129 through 131 inclusive, and 143 through 146 inclusive, all as shown on this map within this subdivision; together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the access easement over, upon, along and across Lot 151, all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over portions of Lots 82 through 94 inclusive, 115 through 118 inclusive, 129 through 131 inclusive, and 143 through 146 inclusive, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, the access easement and the open space easement as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
