BE IT RESOLVED, by the Council of The City of San Diego as follows:

The Planning Department is directed to prepare the following items for Planning Commission consideration at public hearings at the earliest possible date:

1. A comprehensive plan of the Tia Juana River Valley according to Alternative III-A of the Tia Juana River Valley Land Use and Flood Control Alternatives Report utilizing definitive designs for the flood control facility as prepared by the International Boundary and Water Commission.
2. Amendments to the Border Area Plan, adopted on November 9, 1967 by Resolution No. 192115, to include comprehensive plans for the following subareas:
  - a. San Ysidro Community
  - b. Tia Juana River Valley
  - c. Otay Mesa - Brown Field
3. Amendments to the Progress Guide and General Plan for the City of San Diego upon completion of comprehensive plans for the Tia Juana River Valley and Otay Mesa - Brown Field areas.

BE IT FURTHER RESOLVED, that the Planning Commission is further directed to conduct public hearings on the application of the FW and FPF Zones to the appropriate areas within the Tia Juana River Valley.
