
Adopted on NOV 1 - 1973

BE IT FURTHER RESOLVED, that the expenditure of \$4,000 and \$57,600 is hereby authorized out of Community Buildings and Improvement Bond Fund 726 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for said professional services and related expenses.
