
Adopted on NOV 1 - 1973

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of The City of San Diego, an agreement with the COMBINED ARTS OF SAN DIEGO, a nonprofit California corporation, to provide an enriched environment for the cultural and performing arts in order to sustain its citizens and to attract new residents and businesses, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745336.

BE IT FURTHER RESOLVED, that the expenditure of \$165,000 is hereby authorized out of Transient Occupancy Tax Fund 223 solely and exclusively for the purpose of providing funds for the services stated above.
