


RESOLUTION No. 209144

That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with LINDA VISTA HEALTH CARE CENTER, INC., for the purpose of providing comprehensive medical services with emphasis on health maintenance at the least possible cost to patients, and to ensure that services are responsive to community needs as part of the City-County program of using Revenue Sharing Funds for the operation of human care services as approved by Resolution No. 208955 on October 2, 1973, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745345.
