

RESOLUTION NO. 209148 NOV 1-1973

RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REQUESTING A TIME EXTENSION FOR
THE COMPLETION OF IMPROVEMENTS PURSUANT TO
THE COORDINATED RECORDS AND COMMUNICATIONS
SYSTEMS PROJECT.

WHEREAS, this Council, by Resolution No. 206568, adopted September 21, 1972, authorized the City Manager to submit a modified joint application with the County of San Diego for discretionary grant funds from the Law Enforcement Assistance Administration (LEAA) for \$385,000 to assist in the design and implementation of a coordinated records and communications system within the San Diego region; and


WHEREAS, this Council, by Resolution No. 206986, adopted December 5, 1972, requested a time extension from December 31, 1972 to December 31, 1973 for completion of the project; and

WHEREAS, it is now necessary to again request a time extension as a result of delays encountered in execution of a contract with a consultant firm and in the delivery of radio equipment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council requests that the scheduled installation date of the coordinated records and communications systems project be extended from December 31, 1973 to June 30, 1974. Furthermore, that the City Manager is hereby directed to forward a copy of this resolution immediately to the appropriate administrative agency.
