


RESOLUTION No. 209184

Adopted on NOV 6 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$272,326.15 by R.E. Hazard Contracting Co. & W.T. Maxwell Co., a joint venture, for CONSTRUCTION OF MIRAMAR ROAD OVERPASS AT THE ATCHISON, TOPEKA AND SANTA FE RAILROAD TRACKS, including Alternate "A", in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744568.
2. That the expenditure of \$127,500.00 is hereby authorized out of the Gas Tax Fund (220) and that the expenditure of \$190,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MIRAMAR ROAD OVERPASS AT THE ATCHISON, TOPEKA AND SANTA FE RAILROAD TRACKS, including Alternate "A", in the City of San Diego, and related costs.
