

RESOLUTION NO. ~~200197~~ NOV 6 1973

WHEREAS, a certain general utility easement was granted on Lots 734 to 740, inclusive, Lomita Village Unit No. 5, and Lot 1, Lomita Village Unit No. 5 Resub. No. 1, according to map of Lomita Village Unit No. 5 filed in the office of the San Diego County Recorder, June 4, 1953; and

WHEREAS, the owners of the property have requested that the City vacate its interest in said easement to allow better utilization of the land; and

WHEREAS, said general utility easement has never been used for the purpose for which it was granted since the date of filing of said subdivision map to the present time and more than one year has elapsed; and

WHEREAS, a fee of one hundred dollars (\$100) has been collected to cover the processing of this request; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate said general utility easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That, pursuant to Section 50443 of the Government Code of the State of California, the general utility easement more particularly described as follows is hereby vacated:

The Easterly 4.00 feet of Lots 734 through 740, inclusive, Lomita Village Unit No. 5, Map No. 2998, and the Westerly 4.00 feet of Lot 1, Lomita Village Unit No. 5 Resub. No. 1, Map 4681, as granted to the City of San Diego by the filing of said Map No. 2998 of Lomita Village Unit No. 5, in the San Diego County Recorder's Office on June 4, 1953.

That, from and after the date of this order of vacation, title to the land previously subject to said easement shall revert to the owners of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the Recorder of said San Diego County.
