

RESOLUTION NO. 209189 NOV 6 1973

WHEREAS, the Council of The City of San Diego and the San Diego Board of Education have discussed in the past the possibility of a land exchange between the two agencies in order to provide a new site for Point Loma High School; and

WHEREAS, past proposals have not engendered agreement between the parties, and a resolution of this problem acceptable to the City and the San Diego Unified School District has not yet been achieved; and

WHEREAS, the City Council and Board of Education desire to further explore all possible alternatives so that an acceptable solution to this pressing problem may be achieved; and

WHEREAS, both bodies agree that the formation of a committee with representation from the City and the Unified School District is desirable at this time to work toward an acceptable solution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Mayor Pete Wilson, Deputy Mayor Bob Martinet, Councilwoman Maureen O'Connor, City Attorney John Witt and City Manager Kimball Moore and designated staff representatives be and they are hereby designated and fully authorized on behalf of The City of San Diego to serve as a committee for the City to meet with the designated committee of the San Diego

Board of Education to attempt to reach an acceptable land exchange solution for relocation of Point Loma High School.

2. That Mayor Pete Wilson is hereby designated as Chairman of the City's designated representatives.

3. That the above designated committee is directed to proceed as expeditiously as possible toward the accomplishment of the aforementioned objective and submit its recommendations, if and when formulated, to the respective governing bodies for final approval.
