WHEREAS, the Planning Commission held a public hearing on August 22, 1973, for the purpose of considering the proposed "Navajo Community Plan," prepared by the Planning Department in cooperation with the Navajo Community Planners and interested citizens of this area of the City; and

WHEREAS, the plan was developed with the overriding objective for the long-range development of the community that includes: the retention of the residential character of the area, the provision for adequate public services, preservation of the canyons and hillsides in an open character and the enhancement of the environment of the community that is bounded on the north by Mission Gorge Road, on the east by the cities of El Cajon and La Mesa, on the south by Highway 8, and on the west by the San Diego River Channel; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the "Navajo Community Plan;" NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
