1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with WOODWARD-GIZIENSKI AND ASSOCIATES, a California corporation, for geologic-technical services required in connection with preparation of a seismic safety element of the General Plan and with development of a geologic hazards study of the City, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745442.

2. That the expenditure of \$29,000 is hereby authorized from the General Fund (100) of The City of San Diego, Unallocated Reserve, solely and exclusively for the purpose of providing funds for the geologic-technical services described above.
