BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$587,306.75 by Long, Marker & Howley Construction Co., a corporation, for CONSTRUCTION OF LINDA VISTA ROAD 30-INCH WATER PIPELINE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744569.
2. That the expenditure of \$599,200.00 is hereby authorized out of Water Revenue Fund (Fund No. 502) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF LINDA VISTA ROAD 30-INCH WATER PIPELINE in the City of San Diego and related costs.
3. Authorizing the City Auditor to transfer \$85,200.00 within the Water Revenue Fund (Fund No. 502) from the Unallocated Reserve (67.91-3495) to Construction Contract (67.58-3275) for this purpose.
