

Purpose

To establish a procedure to provide copies of the back-up material for the Council docket to the public at a reasonable cost.

Policy

It is the policy of the City Council that:

The complete packets will be available to the public 24 hours after dockets have been delivered to the Mayor and Council. These packets will not be mailed but must be picked up at the City Clerk's office.
