
Adopted on NOV 13 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of Art A. Gussa, Inc., a corporation, is hereby accepted and the City Manager is hereby authorized to execute a contract for HILLSIDE DRIVE STABILIZATION as set forth in the unit prices of Schedules I and II, in an amount not to exceed \$105,900.00 as set forth in Schedule III in accordance with the form on file in the office of the City Clerk as Document No. 745236.
2. That the expenditure of \$128,600.00 is hereby authorized out of the Gas Tax Fund (219) of the City of San Diego solely and exclusively for the purpose of providing funds for HILLSIDE DRIVE STABILIZATION in the City of San Diego, and related costs.
