
Adopted on NOV 13 1973

LEGAL DESCRIPTION

PARCEL 1

All of Lots 3 & 4, Block 290, Seaman and Choate's Addition, according to Map thereof No. 223 filed in the San Diego County Recorder's Office September 10, 1886.

PARCEL 2

All that portion of Lots 43 through 45, inclusive, in said Block 290, more particularly described as follows:

Beginning at the Southwest corner of said Lot 45; thence Northeasterly along a straight line to a point on the Northerly line of said Lot 44, distant thereon 10.31 feet Easterly of the Northwest corner of said Lot 44; thence Easterly along the Northerly line of said Lots 43 & 44, a distance of 25.00 feet to a point on said Northerly line distant thereon 14.69 feet Westerly of the Northeast corner of said Lot 43; thence Southwesterly along a straight line to the Southwest corner of said Lot 44; thence Westerly along the Southerly line of said Lot 45 returning to said Southwest corner of Lot 45, being the Point of Beginning.
