

RESOLUTION No. 209239


Adopted on NOV 13 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LESTER L. ERWIN and ADDIE L. ERWIN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of October 1, 1973, conveying to said City an easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 54, Highdale Addition to Encanto Heights, according to Map thereof No. 1176, filed in the San Diego County Recorder's Office, as more particularly described in said deed, be, and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RADIO DRIVE.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
