in Resolution of Intention No. 209029 is unnecessary
for present or prospective public street purposes.

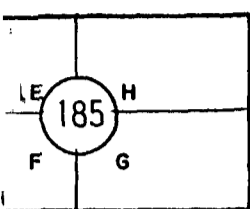
BE IT FURTHER RESOLVED, that 13th Street between A and B Streets;

under seal, to be recorded in the office of the County Recorder.

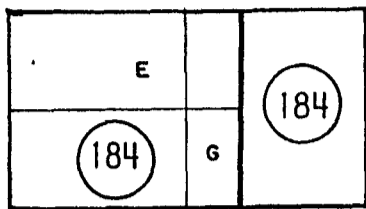
