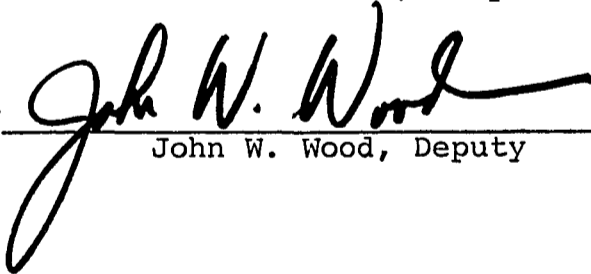
G. SPIKES & W. LOVE MASONRY & CEMENT
