That the bid of Moore Business Forms, Inc. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 500,000 ORIGINAL UTILITY BILLS at a cost of \$7.55 per thousand, 60,000 FIRST OVERDUE BILLS at a cost of \$7.46 per thousand and 30,000 SECOND OVERDUE BILLS at a cost of \$7.46 per thousand for a total cost of \$4,446.40; terms 1.5% 10 days, plus sales tax.
