

RESOLUTION NO. 209266

WHEREAS, the City Council of The City of San Diego has established the attainment and maintenance of "clean air" as a top priority for the citizens of San Diego; and

WHEREAS, the Federal Clean Air Act establishes air quality standards for the nation as a whole and requires that certain implementation plans with appropriate strategies be utilized to achieve the attainment and maintenance of primary and secondary air standards; and

WHEREAS, the Environmental Protection Agency has been promulgating various air control strategies pursuant to a time table established by a federal court decision; and

WHEREAS, the transportation control strategy for the San Diego Air Basin was promulgated by the Environmental Protection Agency on October 30, 1973; and

WHEREAS, this Council deems the matter of the achievement of clean air to be a regional problem and desires to carry out the intent of the Clean Air Act through development of a plan specifically tailored to meet the needs of the San Diego region;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the immediate establishment and formation of a local task force of elected and appointed officials from the San Diego Comprehensive Planning Organization (CPO) and member agencies be recommended to CPO's Board of Directors and that said task force should study and evaluate said transportation control strategy with a view to developing a modified or alternative transportation control plan.

2. That upon establishment of said task force, its members shall submit immediately to CPO's member agencies its recommendations as to timing and staffing requirements necessary to carry out its assignment.

3. Further, that the immediate establishment of a citizens advisory body to assist the above-referenced task force in its duties be recommended to CPO's Board of Directors.

4. That The City of San Diego's designated representative to CPO be authorized to submit these recommendations and a copy of this resolution to CPO's Board of Directors.
