

RESOLUTION No. 209280

Adopted on NOV 20 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$3,000 and \$65,000 from Capital Outlay Fund 245 and Gas Tax Fund 219, respectively, of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the purchase and installation of additional equipment and related costs pertaining to an optical traffic signal preemption system in the downtown area.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above-referenced project by modifying traffic signal controllers and installing and testing the optical system, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
