RESOLUTION OF THE COUNCIL OF THE
CITY OF SAN DIEGO, CALIFORNIA,
ABANDONING PROCEEDINGS AND REJECTING
CONSTRUCTION BIDS AND BOND BIDS

(Mission Boulevard South Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council adopted resolution of intention, Resolution No. 208252, ordering the City Engineer to prepare the Report required by that Act, the City Engineer prepared and filed said Report, and the Council adopted Resolution No. 208428 appointing a time and place of hearing thereon; and

WHEREAS, pursuant to Resolution No. 208604 sealed bids for the construction of a portion of the improvements, designated Contract No. 1, were received and opened by the Purchasing Agent on September 12, 1973; and

WHEREAS, pursuant to Resolution No. 208835 sealed bids for the purchase of bonds to represent unpaid assessments were received and opened by the Purchasing Agent on October 29, 1973; and

WHEREAS, notice of the hearings provided for by Resolution No. 208428 were duly given, the hearings and all continuances thereof were duly held, and, the hearings having been concluded, the Council is of the

opinion that the proceedings should be abandoned and that the construction bids and bond bids should be rejected; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Section 1. The proceedings initiated by resolution of intention, Resolution No. 208252, are hereby abandoned and the City Clerk is directed to file a certified copy of this resolution with the County Recorder of the County of San Diego.

Section 2. All bids for the construction of a portion of the improvements, designated Contract No. 1, are rejected and the Purchasing Agent is directed to return to each bidder the check or bond which accompanied his bid.

Section 3. All bids for the purchase of bonds to represent unpaid assessments are rejected and the Purchasing Agent is directed to return to each bidder the check which accompanied his bid.
