
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ROBERT M. EPLER COMPANY, an independent contractor, for a study of the feasibility of self-insuring the City's group health insurance program.

BE IT FURTHER RESOLVED, that the transfer of \$14,600 is hereby authorized from the Unallocated Reserve 100 Fund to the Employee Services Department (04.90 - 3295), solely and exclusively for the purpose of providing funds for the above described study.
